CREATION OF THE COMMITTEE ON ANTI-RED TAPE (CART) IN THE

DA-BUREAU OF AGRICULTURAL RESEARCH

In the interest of service and to ensure the compliance of the Department of Agriculture-Bureau of Agricultural Research (DA-BAR) to the Republic Act No. 11032 otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 and the DA Special Order 2021-576 creating the DA Committee on Anti-Red Tape (CART), the DA-BAR SO 2021-40 constituting the DA-BAR Citizen's Charter Technical Working Group (TWG) is repealed/revoked in favor of the creation of the DA-BAR CART.

On top of the duties and responsibilities itemized in the DA SO 2021-576 (as may be applicable), the DA-BAR CART shall have following functions and responsibilities:

- 1. Update and package the DA-BAR Citizens Charter (External and Internal Services);
- 2. Facilitate public dissemination of the Citizen's Charter through the BAR website, electronic billboards, posters, or any other readable materials that could be easily understood by the clients;
- 3. Monitor, process and analyze the client satisfaction or feedback and visitor's complaint forms; and
- 4. Facilitate submission of the Citizen's Charter Handbook, Certificate of Compliance, Compliance Report and other relevant and related documents to the Anti-Red Tape Act Authority.

As such, all above-mentioned officials and staff are entitled to reimburse meals, travel, compensatory time off-setting and other incidental expenses covering their role as a member of the DA-BAR CART. In addition, all divisions and units are to extend full support and cooperation at all times to the DA-BAR CART as may be necessitated along the course of their duties.

This Order shall take effect immediately and shall remain in force until revoked in writing.
