The BAC shall have the following functions: advertise and/or post the invitation to bid, conduct pre-procurement and pre-bid conferences; determine the eligibility of prospective bidders; receive bids; conduct the evaluation of bids; undertake post-qualification of proceedings; recommend award of contracts to the Head of Procuring Entity (HOPE) or his duly authorized representative and perform such other related functions as maybe necessary, including the creation of Technical Working Group from a pool of technical, financial and/or legal experts to assist in the procurement process.

The BAC shall be responsible for ensuring the Procuring Entity abides by the standards set forth by R.A. No. 9184 and the IRR, and it shall prepare a procurement monitoring report that shall be approved and submitted by the Procuring Entity to the GPPB on a semestral basis.

Section 11.2.4 of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 provides that alternate members of the BAC, designated by the Head of the Procuring Entity (HoPE), and with the same qualifications as that of the original members designated under Section 11.2.2 of the 2016 IRR, shall attend meetings of the BAC and receive the proportionate honoraria, whenever the original members are absent.

The Secretariat shall act as central channel of communications, provide administrative support to the BAC and TWG, and assist the BAC in the conduct of its functions among others.

This order takes effect immediately and shall remain in force in force until revoked.
