AMENDMENT TO SPECIAL ORDER NO. 289, SERIES OF 2024

REVOCATION OF SPECIAL ORDER NO. 260 SERIES OF 2024 AND DESIGNATION OF MR. RYAN JOSEPH M. ABRIGO AS OFFICER-IN-CHARGE (OIC)-HEAD OF THE TRANSPORTATION MAINTENANCE AND SERVICES

UNIT

In the interest of the service, Special Order No. 289, Series of 2024 designating Mr. Ryan Joseph M. Abrigo, as OIC-Head of the Transportation Maintenance and Services Unit is hereby amended to include responsibilities related to the facilitation of the bureau's security services, in concurrent capacity to his functions as Information Systems Analyst II to the Information Management Section- Knowledge Management and Information Systems Division (KMISD).
