REVOCATION OF SPECIAL ORDER NOS. 4¹ and 6², SERIES OF 2024 AND DESIGNATION OF MR. RYAN JOSEPH M. ABRIGO AS OIC-HEAD OF THE ADMINISTRATIVE AND FINANCE DIVISION-GENERAL SERVICES UNIT

In the interest of the service, the following issuances are hereby revoked:

He is entitled to travelling expenses, communication expenses, per diems, and incidental expenses that may be incurred in the performance of his functions, duties, and responsibilities, chargeable against DA-BAR funds, subject to existing government accounting and auditing rules and regulations.

All officials and employees of the Bureau are hereby advised of this designation and directed to give their full support and cooperation to Mr. Abrigo in the performance of his duties and responsibilities.


This Order shall take effect immediately and shall remain in force unless revoked in writing. All orders, memoranda, and issuances inconsistent herewith are deemed revoked.
