

CONTRACT AGREEMENT

RECEIVED

THIS AGREEMENT made on the JUN 04 2025 day of JUN 20 between DEPARTMENT OF AGRICULTURE - BUREAU OF AGRICULTURAL RESEARCH (DA-BAR) of the Philippines (hereinafter called "**the Entity**") of the one part and NEW A.G. STYLIST FURNITURE of 132 Aurora Blvd San Juan Metro Manila, (hereinafter called "**the Supplier/Service Provider**") of the other part;

WHEREAS, the **Entity** invited Bids for certain goods and ancillary services, particularly for the "**Lot 1 Office Equipment and Lot 2 2.0 HP Airconditioner**" under **PR No. 2025-04-214** and has accepted a Bid by **the Supplier** for the supply of those goods and services under Small Value Procurement in the sum of **EIGHT HUNDRED NINETY-SIX THOUSAND SEVEN HUNDRED PESOS (P896,700.00)**. (hereinafter called "**the Contract Price**").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the Implementing Rules and Regulations of Republic Act No. 12009 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:

Request for Quotation;

1. Schedule of Requirements;
2. Technical Specifications; and
3. Supplemental or Bid Bulletins, if any

3. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;


Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

4. Notice of Award of Contract; and the Bidder's *conforme* thereto; and
5. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

6. In consideration for the sum of **EIGHT HUNDRED NINETY-SIX THOUSAND SEVEN HUNDRED PESOS (P896,700.00)** or such other sums as may be ascertained, New A.G. Stylist Furniture agrees to **Supply, Install and Deliver Lot 1 Office Equipment and Lot 2 2.0 HP Airconditioner** under **PR No. 2025-04-214** in accordance with his/her/its Bid.

7. The **DEPARTMENT OF AGRICULTURE - BUREAU OF AGRICULTURAL RESEARCH (DA-BAR)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




