WHEREAS, the Department of Agriculture – Bureau of Agricultural Research under the Planning and Monitoring Unit allocated the amount of TWO MILLION EIGHT HUNDRED SEVENTY-FOUR THOUSAND SIX HUNDRED PESOS (\$\mathbb{P}2,874,600.00)\$ as indicated in the approved Purchase Request No. 2025-05-269 dated May 19, 2025 and will be acquired pursuant to Section 35.7 (Engagement of Highly Technical Consultants) of the Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 12009.

WHEREAS, said engagement was through Negotiated Procurement for Section 35.7 (Engagement of Highly Technical Consultants) whose consultants hired to do work are highly technical consultant and primary confidential and that term of the individual consultant shall, at the most be on a yearly basis, renewable at the option of the appointing hope, but in no case shall exceed the term of the latter.

WHEREAS, the said procurement process is also in accordance with approved Memorandum from the Director dated May 6, 2025, re: Implementation of Section 35.7 of the New Government Procurement Act or RA 12009 - Engagement of Highly Technical Consultants.

WHEREAS, as per the approved Purchase Request dated May 19, 2025, its attachments containing 1. Approved Justification, 2. Approved Terms of Reference, 3. Curriculum Vitae, 4. PHILGEPS Registration, and 5. Bureau of Internal Revenue (BIR) Certificate of Registration, the Bids and Awards Committee (BAC) found that MR. ROMEO S.
